## EDITORIAL BOARD

### Ruby S. Alleyne, PhD

Dr Ruby S. Alleyne is the Vice President, Quality Assurance and Institutional Effectiveness at the University of Trinidad and Tobago (UTT). Prior to this, she served as Executive Director of The Accreditation Council of Trinidad and Tobago (ACTT) from 2005 to 2009.

Dr Alleyne holds a degree of Doctor of Philosophy in Education from The University of the West Indies (UWI). She specialises in educational administration, quality assurance and accreditation.

She has worked extensively in the field of quality assurance in the Caribbean region, providing technical support and training for national accreditation bodies in 10 member states, including Barbados, Guyana, the Organisation of Eastern Caribbean States (OECS) countries, Belize and Suriname. She currently serves as Vice President, Accreditation Activities of the Caribbean Accreditation Council for Engineering and Technology (CACET).

Her publications include: "Cultures, structures and strategies: A study of organisational configurations in the tertiary education sector in Trinidad and Tobago", Vol. 1 No. 1, 2004, *Caribbean Educational Research Journal* and "Shaping the curriculum: Conceptions of excellence in secondary education in Trinidad & Tobago", Vol. 3 No. 2, 1993, *Caribbean Curriculum*.

### Robertine Chaderton, PhD

Dr Robertine Chaderton is an academic and an accountant. She holds a Bachelor of Science in Math & Physics from The University of the West Indies, Bachelor of Commerce from the University of Windsor, a Doctorate in Accounting from the University of Manchester, as well as being a Fellow of the Association of Chartered Certified Accountants (FCCA) of the United Kingdom.

Dr Chaderton has been on the Board of the St Kitts and Nevis Accreditation Board since 2002 and became the Chairperson in 2009. She has been the team leader and participated in the accreditation of institutions across the Caribbean. She is currently a Senior Lecturer with The University of the West Indies and has held senior positions in financial institutions in the Caribbean.

Dr Chaderton's most recent publication is *Managing Your Money: The Caribbean Person's Guide to Financial Independence* (2nd ed 2012). In 2004, ACCA recognised her as one of the top 100 accountants worldwide during their centenary celebrations.

### Franz Gertze

Mr Franz Gertze is the Chief Executive Officer (CEO) of the Namibia Qualifications Authority (NQA), where he gained extensive experience in the fields of qualifications, standards setting, accreditation, assessment and the National Qualifications Framework (NQF).

Under his leadership, the NQF was established and firmly entrenched in the education system of Namibia. He was first qualified as a teacher before he studied Business Administration and Quality Management, and worked as an English Teacher, Head of Department and a Quality Officer at the NQA before becoming its CEO. Mr Gertze has also been involved with the conceptualisation of the Regional Qualifications Framework for Southern Africa (SADCQF), the Transnational Qualifications Framework (TQF) for the Commonwealth of Learning, as well as the UNESCO/OECD Guidelines on Quality Provision in Cross-border Higher Education.

In the field of quality, he is registered with the International Register of Certificated Auditors (IRCA) as a qualified ISO 9001 Assessor and is also a European Foundation for Quality Management (EFQM) Assessor. Mr Gertze is a member of several boards and bodies such as the Namibia Training Authority Board, Namibia Institute of Public Administration and Management, South African Development Community (SADC) Technical Commissions, Transnational Qualifications Framework (TQF) and the International Network for Quality Assurance Agencies in Higher Education (INQAAHE).

### Sandra Ingrid Gift, PhD

Dr Sandra Ingrid Gift is Senior Programme Officer and Head of the Quality Assurance Unit, the Vice Chancellery of The University of the West Indies (UWI), St Augustine Campus in Trinidad and Tobago. She has 30 years experience in the field of education, with 20 years dedicated to supporting the work of the United Nations Educational, Scientific and Cultural Organization (UNESCO) nationally, regionally and internationally.

She is a member of the International Network of Quality Assurance Agencies for Higher Education (INQAAHE), and of regional bodies for the promotion of quality in higher education. In 2011, Dr Gift was presented with the Excellence in Higher Education Quality Assurance Award by The Accreditation Council of Trinidad and Tobago (ACTT).

Dr Gift has participated in numerous regional and international training activities and conferences on quality assurance in higher education, and has authored several publications in the field. She is the author of *Maroon Teachers: Teaching the Transatlantic Trade in Enslaved Africans*. Her current research interests relate to best practice in higher education and the internationalisation of higher education.

### Ethley London, PhD

Dr Ethley London has been involved in quality assurance in higher education in the Caribbean for over 25 years. She served as the founding Executive Director of the University Council of Jamaica (UCJ) from its inception in 1987 until 2011, and has led the Council to become a credible national body which has gained worldwide recognition.

She serves as director of a number of national organisations, and internationally, has served on the Board of the International Network of Quality Assurance Agencies in Higher Education (INQAAHE) from 1999 to 2003. She spearheaded the formation and establishment of the Caribbean Area Network for Quality Assurance in Tertiary Education (CANQATE) in 2004, and served as its first president.

As a consultant in quality assurance, she has assisted several other Caribbean countries in establishing their national accreditation bodies. She has authored publications in tertiary education and quality assurance and has made numerous presentations at regional and international conferences.

### Gillian Paul, PhD

Dr Gillian Paul is the President (Ag) of the College of Science, Technology and Applied Arts of Trinidad and Tobago (COSTAATT), having served in her substantive post as Vice President Academic Affairs since the establishment of the College. She holds a Doctorate in Higher Education Administration from Columbia University.

Dr Paul served as the Director of the School of Languages of the National Institute of Higher Education, Research Science and Technology (NIHERST) and she was also a member of the NIHERST team that was given responsibility for the establishment of COSTAATT. She also served as the President of the Association of Caribbean Higher Education Administrators (ACHEA) from 2004 to 2008.

For over two decades, Dr Paul has been involved in developmental work in the areas of foreign language education, curriculum development, quality assurance and accreditation, educational reform, policy formulation and implementation, teacher education and professional development, distance education and technology in education.

She has delivered numerous presentations, conference papers and workshops on these topics and has had the opportunity to share her passion and commitment to educational development



through service on several national committees including the Cabinet-appointed National Advisory Council on Education (NACE), the National Curriculum Council, the National Task Force on a Seamless Education System and the Tertiary Education Policy Review Committee.

### Lynn E. Priddy, PhD

Dr Lynn E. Priddy serves as Provost and Chief Academic Officer of National American University, an institution that offers associate, baccalaureate, master's, and doctoral degrees. As Provost, she oversees all aspects of the educational enterprise of the institution. Prior to joining National American University in 2013, Dr Priddy served as Vice President for Accreditation Services for the Higher Learning Commission of the North Central Association of Colleges and Schools, United States. As Vice President of the largest regional accreditation agency in the United States, she was responsible for the accreditation processes, including the decision process, the peer corps and peer review, education and training, and the Academy for Assessment of Student Learning, for which she was the founding director.

In her 14-year tenure at the Commission, Dr Priddy played a pivotal leadership role in the conceptualisation of the Commission's new accrediting process, Pathways, the development of the 1600+ member Peer Review Corps, the establishment of AQIP, the alternative accrediting process based on continuous quality improvement principles, and the founding of the Academy for Persistence and Completion.

Dr Priddy is a summa cum laude graduate of Capella University with a Doctor of Philosophy in Higher Education: Educational Assessment, Evaluation, and Research. She is a frequent national and international speaker and facilitator on assessment and improvement of student learning, student persistence and completion, institutional accountability and effectiveness, accreditation, and higher education.

### María José Lemaitre

Professora María José Lemaitre, Executive Director of Centro Interuniversitario de Desarrollo (CINDA), a network of universities in Latin America and Europe, is the past president of the International Network for Quality Assurance Agencies in Higher Education (INQAHE), a board member of the Ibero-American Network for Quality Assurance in Higher Education (RIACES), and currently serves on the Advisory Committee for the Council for Higher Education Accreditation (CHEA) International Quality Group.

She was in charge of quality assurance processes in Chile between 1990 and 2007; has published extensively and provided consultancy services on higher education policy and quality assurance to multilateral agencies, governments and higher education institutions in South and Central America, the Caribbean, the Middle East, Africa, Eastern Europe and Southeast Asia.

### Jerome Teelucksingh, PhD

Dr Jerome Teelucksingh is a lecturer in the Department of History at The University of the West Indies (UWI), St Augustine Campus in Trinidad and Tobago. He has served as a part-time lecturer at the University of Trinidad and Tobago (UTT). He currently serves as a member of Industrial Relations Advisory Committee and is the Vice Chairman of the Board of Governors of the Cipriani College of Labour and Co-operative Studies (CLCS).
