The award for *Excellence for an Established Quality Management System* is ACTT's premier award and represents the highest level of implementation of a quality system at an institution.

An effective Quality Management System (QMS) begins with a demonstrated commitment to quality by all institutional personnel through the implementation of its quality policy. Implementing an effective QMS requires commitment of dedicated resources to ensure sustainability. Significant financial resources must be allocated to the initial implementation of a QMS, its ongoing maintenance, as well as future initiatives to ensure continuous improvement. Institutions must also invest in recruitment of suitably qualified quality professionals and plan to invest in their ongoing professional development.

An effective QMS will facilitate constant review and update of an institution's processes to ensure that its quality objectives identified in the quality policy are met.

- 1. Quality Management Policy
- 2. Dedicated Resources for the Quality Management System
- 3. Stakeholder Analysis
- 4. International Best Practice
