Failure to comply with any of these instructions may result in the application not being considered.

All interested applicants are asked to note the following:

- Applicants may apply for as many categories as they wish
- Applications must be accompanied by:
 - a valid Income Tax Certificate
 - a valid VAT Clearance Certificate
 - a valid NIB Compliance Certificate

In the case of companies, firms and other business entities, the application must be accompanied by the appropriate Certificate of Incorporation/Certificate of Registration/Certificate of Continuance to establish the legal identity of the company.
